

Eighteen volunteers from <u>St. Francis Builds</u>, a program based at <u>St. Camillus Parish</u> in Silver Spring, Maryland, <u>traveled to Puerto Rico</u> in late July to continue recovery work on the island, which was devastated by Hurricane Maria in September 2017. Eighth-grader Rosali Patterson, who with her twin sister and family are members of St. John Fisher Parish in Portland, Oregon, has worked with fellow classmates at St. John Fisher School to fabricate plastic prosthetic hands for potential use by underprivileged children. The device is created by use of a 3D printer. A YouTube video explains the program.

Speaking of Catholic schools, all of them in the Diocese of Palm Beach, Florida, offer specialized programs and assistance for students identified as having specific learning needs.


The main crops of the one-acre garden overseen by <u>Tom Rohr</u> are potatoes, tomatoes, peppers, cucumbers and green beans. A member of <u>St. Vincent de Paul Parish</u> in Rogers, Arkansas, Rohr's garden ministry annually raises 10,000 pounds of produce for the parish food pantry.

The embezzlement trial for Fr. Jonathan Wehrle, formerly pastor of <u>St. Martha Parish</u> in Okemos, Michigan, in the Lansing Diocese, has been <u>postponed</u> until January.
